## Membership of the Local Governing Board and Register of Business Interests 2021/22

All Governors and Associate Members are required to declare any personal, pecuniary or business interests on their appointment, and also are reminded to update this information at every meeting of their full Governing Body and its Committees. This published Register will be updated annually after the first meeting of the school year; however, any changes made during the year will be recorded in the Minutes of the meeting at which they are declared. This document was last updated on 04/05/2022 and is accurate to that date. Please note that, from 1<sup>st</sup> September 2017 to 31<sup>st</sup> August 2021, St. Peter's Primary School has been operating on the basis of a Local Advisory Board and, since 1<sup>st</sup> September 2021, as a Local Governing Board, as designated by its parent body, Folio Education Trust. The Local Advisory/Governing Board legally operates on a similar basis to a Governing Body in terms of legislative requirements such as publication of its Register of Interests. The Local Governing Board currently has no separate Committees.

Co-opted Governors are appointed by the Local Advisory Board. Parent Governors are elected by the school's parents and carers.

Staff Governors are elected by the school's staff other than the Headteacher whose place is automatic from start date in post unless a Headteacher declines it – with the appointment from 1<sup>st</sup> April 2018 of two Acting Co-Heads of School (made permanent during the Summer Term of 2019 as Co-Headteachers resulting in dropping of the word "Acting" from the title), one has taken the Headteacher governorship and an additional post on the Board has been created for the other.

Observers are not Governors, but may sit on the Local Governing Board, usually because they have specific skills and they therefore hold similar entitlements to Associate Members of regular Governing Bodies. They can be appointed for between one and four years. Our Observers currently do not have any voting rights.
